## **FOREWORD**



As we stand at the dawn of a new legislative cycle with a new EU Parliament and Commission, we find ourselves at a pivotal moment as we launch our 2025+ Work Programme. This significant transition brings a renewed focus on the strategic priorities and ambitions of EU leadership, that will shape the future direction of the European Union. While we embrace new initiatives aimed at driving progress, the European Court of Auditors (ECA) remains dedicated to tackling the persistent challenges that have arisen in recent years, ensuring that the lessons learned from the past inform our commitment to achieving future objectives.

As we step into this new chapter together, the ECA's role as the European Union's independent external auditor remains constant. We are tasked with ensuring that EU funds are raised and spent in line with relevant regulations and that they achieve their intended outcomes. With increasing EU spending comes greater budgetary risks, as well as challenges in maintaining sound financial management and the effectiveness of public intervention.

Our 2025+ Work Programme has been developed with these considerations in mind. You will find below a list of the **69 special reports and reviews** we intend to publish in 2025 and 2026. Furthermore, we will publish yearly our annual reports which represent the results of our financial and compliance audit work.

In our first strategic area of focus, *The Union's economic competitiveness*, we will explore critical audit tasks related to topics such as the microchip industry, digital payments, suburban passenger transport, and labour market reforms. These areas align closely with the EU's objective to enhance its competitiveness in a rapidly evolving global landscape.

Security and migration have become increasingly significant concerns at the EU level in recent years and are addressed in our audit work under the strategic priority area of *Resilience to threats* to the Union's security, and respect for the European values of freedom, democracy and rule of law. Our efforts will focus on areas such as, nuclear safety cooperation, large-scale cyber-attacks, the Union Civil Protection Mechanism, and education in the least developed countries.

While new priorities emerge, **combating climate change** remains a crucial aspiration for the EU, underscored by its ambitious 2030 targets. Our work programme focuses on that within the strategic priority area of *Climate change, the environment, and natural resources*. We plan to publish several reports addressing various aspects of energy, including critical raw materials for the energy transition, modernising EU electricity grids, Innovation Fund for green transition, as well as looking at the EU Chemicals Regulation (REACH) and forest wildfires.

In addition to our focus on specific strategic areas, we will continue to evaluate the **Recovery and Resilience Facility (RRF)**, concentrating on key issues such as business environment reforms, investments in energy efficiency, as well as undertaking a stocktake review of our audit work performed on the facility. Moreover, several audits will address the overarching theme of **combating fraud**, including the EU's anti-fraud strategy and the collaboration between EU bodies fighting fraud.

In the coming years, we look forward to collaborating with EU institutions and bodies, as well as national authorities, to implement this work programme. Our goal is that together we can foster greater public trust while enhancing the management and oversight of EU funds. To achieve this, we will continue to equip ourselves with the necessary tools and skills to effectively navigate the challenges we face in this evolving environment.


